

TRINITY TIDBITS

A monthly newsletter for the people of Trinity Lutheran Church of Sealy, Texas

To the Congregation of Trinity Lutheran:

Trinity Lutheran Preschool has been a ministry outreach to the children of the Sealy community, offering early childhood education for over 30 years. Due to the restrictions placed on schools in reaction to the Covid-19 Pandemic, the Preschool Board made the decision to suspend classes beginning in March 2020, leaving the Preschool with no income. During this time, the Preschool has remained in compliance with the regulations required by the Federal Government Licensing Agency.

The Preschool obtained a Payroll Protection Plan Loan from the Government, which requires no repayment. The school also applied for and received, an additional \$7,000.00, which goes into repayment this month. This loan was through the EIDL Program (Economic Injury Disaster Loan). Other than these loans, the Preschool has been operating on funds that had been collected prior to March. These funds will be depleted before the beginning of the 2021-2022 school year, before tuition will begin to be collected. The Preschool will need an estimated amount of \$30,000.00 in order to reopen again in the fall of 2021. Furthermore it will take months for the Preschool to have a positive cash flow. The loan is primarily needed for payroll and the Preschool is asking the Church to consider options to help.

Other Actions taken by the Preschool

- Tuition that had been paid for March, April and May of 2020, was refunded, if the parents requested to be reimbursed.
- Teacher salaries were paid to the end of the year, and through the summer for those teachers who have their pay set up in that way.
- The Preschool Director has been receiving half salary, but will go back to full salary in March of 2021.
- Currently, the Preschool has monthly expenses, including salary, of approximately \$1,500.00, plus any annual inspections or licensing fees that may be due.
- In March of 2021, registration fees will begin to be collected and tuition will begin to be collected in September.
- The Preschool Board voted to increase the cost of tuition for the next school year.
- Prior to the Pandemic, the Preschool had made improvements to the playground, which was a large expense to the school.

Options for the Church to help

- The Church could borrow the funds from a bank for the Preschool. The school was not able to obtain a loan on its own, since there is no income. Therefore, the Church would be required to make the payments.
- The Church could loan the Preschool money from funds that the Church has available. This loan could be in advances, only funded when there is a deficit in the Preschool's funds.
- Both of these options will require a repayment plan from the Preschool.

Important Points to Consider

- The Church recently paid \$59,000.00 from the General Fund for the new Heating/AC system.
- The Church also has an outstanding \$50,000.00 loan for the Heating/AC system that has just begun repayment. The payment for this loan is \$1,499.04 a month. An additional \$30,000.00 loan will increase the amount that the Church will owe on a monthly basis.

- There is still so much unknown about what the requirements will be by the State for the next school year...such as how many students will be allowed per classroom. Fewer students will mean less tuition, which equates to less cash flow for the Preschool. This would mean that it will take the Preschool longer to repay the loan.
- It is also unknown if parents will be willing to send their children to Preschool next fall, as well as be able to pay the higher tuition costs.
- If nothing is done for the Preschool, it will most likely have to close for at least the next school year and begin the process of getting re-licensed in order to re-open.

Trinity Preschool is part of Trinity Lutheran Church and has been a wonderful outreach for the Church, being the only Christian Preschool in Sealy. The Congregation has an important decision that has to be made. Please pray as you consider what the best option is.

There will be a special Congregational meeting in January for the congregation to vote on this matter. We will have to consider what is best for the Preschool and the Congregation. Please make every effort to attend this very important meeting.

This balance reflects a payment made for the Heat/AC system in the amount of \$59,738.00.
